## 2010 Port Gibson Heritage Festival

### FOOD VENDOR CONTRACT

The following contractual agreement is made between: \_\_\_\_\_  
("Vendor") and Port Gibson Heritage Festival. Responsibilities of both parties are as follows.

1. Fee of \$\_\_\_\_\_ to be paid by Vendor no later than March 12, 2010 to Port Gibson Heritage Festival. This year's Festival will be March 27, 2010.
2. Port Gibson Heritage Festival reserves the sole right to select qualified vendors to participate in the Festival. Selection will be based on factors to minimize duplication of product and maximize quality and variety. There will be no exclusives.
3. Hours of operation are 8:00 a.m. until dusk. Because of traffic congestion no Vendor will be permitted to leave his assigned location until authorized to do so by Food Court Chairperson.
4. Coffee and hot tea may be sold by Food Vendors. Food Vendors may not sell any other beverages including soft drinks, lemonade, iced tea, bottle water, or shaved ice products. Any Vendor not adhering to this policy may be shut down for the duration of the Festival.
5. All Vendors are required to submit the provided State of Mississippi Sales Tax Return prior to leaving the Festival. Sales Tax payments must be cash only.
6. Vendors must follow State of Mississippi health permit guidelines.
7. Vendors will be notified of their selection to participate upon receipt of application.
8. The following policies will be in effect.
  - a. Non-discrimination – Port Gibson Heritage Festival is sponsored by Port Gibson Main Street, Inc. a 501(c)3 corporation whose policy is not to discriminate on the basis of race, color, creed, national origin, sex, sexual orientation, or disability. During the Festival it is expected that all Vendors and their representatives will adhere to a similar policy and anyone deemed not to be adhering to such policy will be asked to leave the Festival.
  - b. No Alcohol Sales – No Vendor will be allowed to sell or distribute alcoholic beverages of any kind during the Festival.
  - c. Rain or Shine. This is an outdoor street festival; no refunds will be made for Vendor cancellation or inclement weather.
